6. Did you or any agent of OFC have any communication with any agent of the Nearman campaign regarding the piece of campaign literature? If yes, provide the name and contact information of the agent(s) involved.
7. Were the expenses incurred for the piece of campaign literature reported in ORESTAR? If yes, please provide the transaction id numbers associated with the payments.
