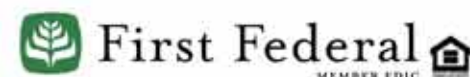
When he's not on duty, Diaz may be found outdoors hunting or fishing. Or he may be indoors, watching games played by Boston sports teams.

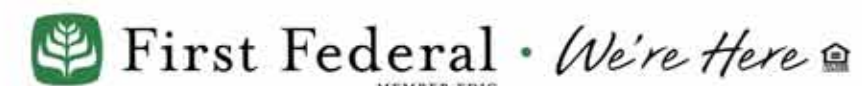

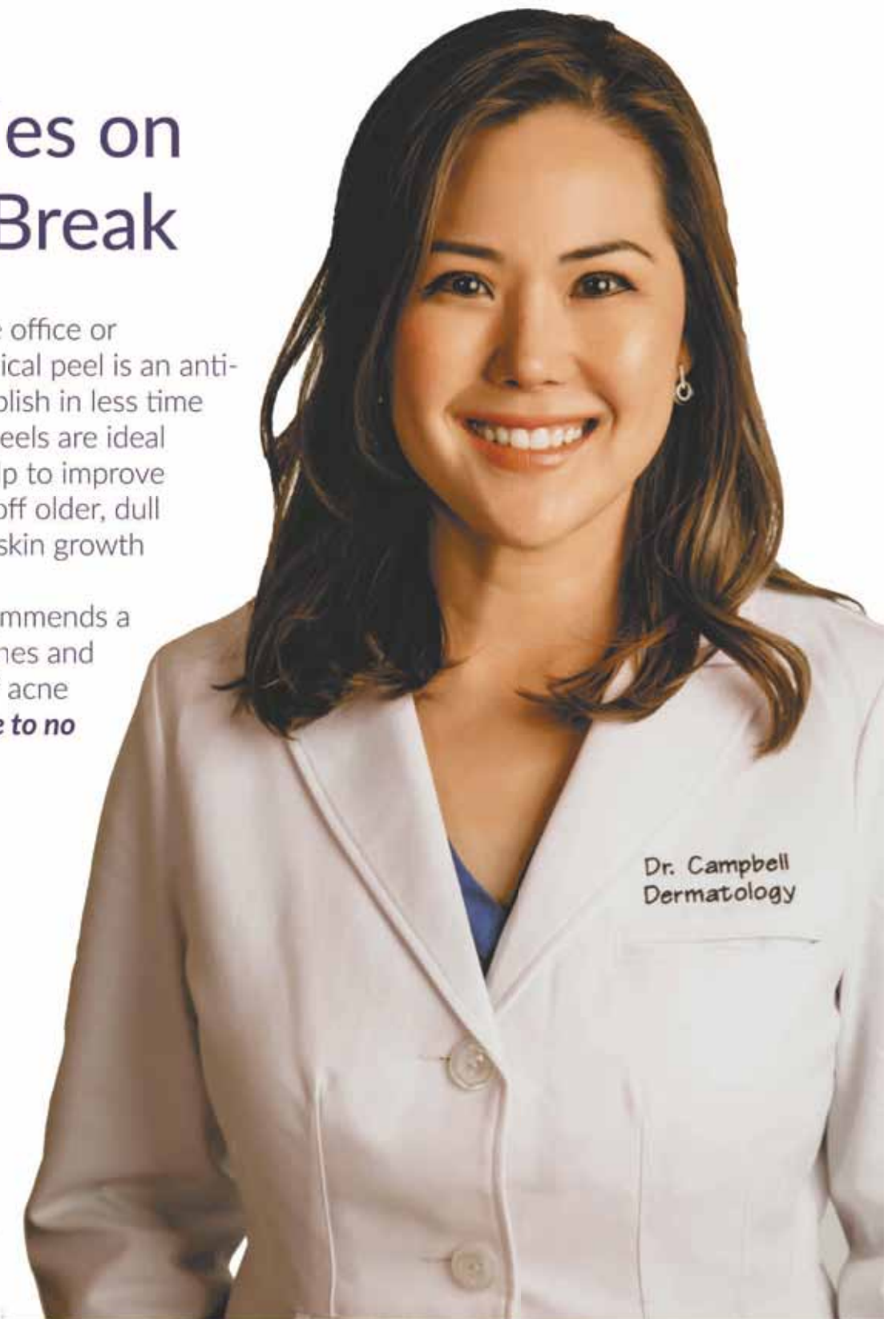

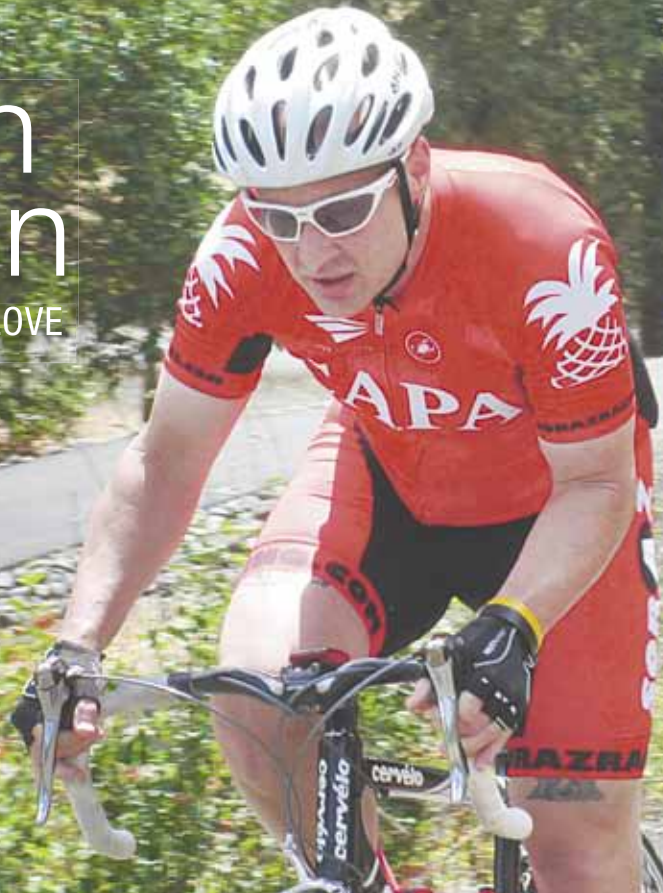
